

FACTS	WHAT DOES DITECH FINANCIAL LLC (“Ditech”) DO WITH YOUR PERSONAL INFORMATION?	
<b>Why?</b>	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.	
<b>What?</b>	The types of personal information we collect and share depend on the product or service you have with us and can include: <ul style="list-style-type: none"> <li>• Social Security number and income</li> <li>• Account balances and payment history</li> <li>• Credit history and mortgage rates and payments</li> </ul>	
<b>How?</b>	All financial companies need to share customers’ personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers’ personal information; the reasons Ditech chooses to share; and whether you can limit this sharing.

<b>Who is providing this notice?</b>	<b>Ditech Financial LLC</b>
<b>What we do</b>	
<b>How does Ditech protect my information?</b>	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings. Our security practices include limiting access to this information to those employees and business associates with appropriate authority and for intended business purposes only.
<b>How does Ditech collect my personal information?</b>	<p>We collect your personal information, for example, when you</p> <ul style="list-style-type: none"> <li>• Apply for a loan or give us your income information</li> <li>• Provide employment information or give us your employment history</li> <li>• Provide your mortgage information</li> </ul> <p>We also collect your personal information from others, such as credit bureaus, affiliates or other companies.</p>
<b>Why can't I limit all sharing?</b>	<p>Federal law gives you the right to limit sharing only</p> <ul style="list-style-type: none"> <li>• Affiliates' everyday business purposes – information about your credit worthiness</li> <li>• Affiliates from using your information to market to you</li> <li>• Sharing for nonaffiliates to market to you</li> </ul> <p>See below for more on your rights under state law.</p>
<b>What happens when I limit sharing for an account I hold jointly with someone else?</b>	Your choices will apply to everyone on your account.
<b>Definitions</b>	
<b>Affiliates</b>	<p>Companies related by common ownership or control. They can be financial and non-financial companies.</p> <ul style="list-style-type: none"> <li>• <i>Our affiliates include financial companies such as Green Tree Credit LLC; Green Tree Loan Company; Green Tree Insurance Agency, Inc.; Green Tree Agency, Inc.; Green Tree Insurance Agency of Nevada, Inc.; Green Tree Insurance Agency Reinsurance Limited; Green Tree Investment Holdings III LLC; Green Tree Investment Holdings II LLC; Reverse Mortgage Solutions, Inc.; and Walter Investment Management Corp.</i></li> </ul>
<b>Non-affiliates</b>	<p>Companies not related by common ownership or control. They can be financial and non-financial companies.</p> <ul style="list-style-type: none"> <li>• <i>Nonaffiliates we share with can include providers of financial services or insurance, such as mortgage bankers or insurance companies and agents and non-financial companies such as retailers, direct marketing companies or contractors.</i></li> </ul>
<b>Joint marketing</b>	<p>A formal agreement between non-affiliated financial companies that together market financial products or services to you.</p> <ul style="list-style-type: none"> <li>• <i>Our joint marketing partners include providers of financial services or insurance, such as mortgage bankers or insurance companies and agents; and non-financial companies, such as retailers, direct marketers or contractors.</i></li> </ul>
<b>Other important information</b>

## North Dakota Privacy Notice

### Information Ditech Collects About You

We collect nonpublic personal information about you from the following sources:

- Information we receive from you on applications or other forms;
- Information about your transactions with us, our affiliates or others; and
- Information we receive from a consumer reporting agency.

### Information Ditech Shares About You

We may disclose all of the information that we collect, as described above. When you are no longer our customer, we may continue to share your information as described in this notice.

### Third Parties with Whom Ditech Shares Information About You

We may disclose nonpublic personal information about you to the following types of third parties:

- Financial service providers, such as mortgage lenders, mortgage brokers, and title companies; and
- Non-financial companies, such as retailers, direct marketing companies or contractors.

We may also disclose nonpublic personal information about you to third parties as permitted by law.

### Service Providers with Whom Ditech Shares Information About You

We may disclose all of the information that we collect, as described above to companies that perform services on our behalf.

### Your Opt-In Rights

We will not disclose nonpublic personal financial information about you to nonaffiliated third parties (other than as permitted by law) unless you authorize us to make that disclosure. Your authorization must be in writing or, if you agree, in electronic form. If you wish to authorize us to disclose your nonpublic personal financial information to nonaffiliated third parties, you may complete, sign and mail to us the form on the following page.

### How Ditech Protects Your Information

We restrict access to nonpublic personal information about you to those employees who need to know that information to provide products or services to you. We maintain physical, electronic, and procedural safeguards that comply with state and federal regulations to guard your nonpublic personal information.

## North Dakota Opt-In Authorization

By completing the information and signing below, I authorize Ditech Financial LLC (“Ditech”) to disclose my nonpublic person information to affiliates and nonaffiliated third parties. Ditech may consider this as my written authorization under North Dakota law for such disclosure. Nothing in this authorization requires Ditech to disclose such nonpublic person information.
